

## PROOF OF DELIVERY AND RECEIPT

Undersigned György Länger (address: H-2014 Csobánka Gyöngyvirág u. 11.), as the owner of Szürkebarát pumi kennel (hereafter Breeder) in exchange for the mutually accepted amount of (.....) conveys to ..... (address: ..... ) (hereafter Owner) the ownership rights of the pumi puppy, born in his kennel from ..... parents, on the date of ..... , pedigree name: ..... , pedigree number: ..... , color: ..... , gender: ..... , microchip number: .....

under the following conditions:

1. Breeder overhands the puppy with the Pedigree Certificate of Origin transmitted by the MEOE (Hungarian Kennel Club), treated against worms ..... times, vaccinated ..... times (see in pet passport and vaccinations document).
2. Owner is obliged to keep the puppy in appropriate conditions (for a pumi being tethered, being held in a cage or a narrow kennel permanently is not adequate). Owner is obliged to groom and feed the puppy, provide it with veterinary attendance, have it wormed and vaccinated, and to take care of it.
- If, due to an unforeseen, acknowledgeable reason, it is no longer possible for the Owner to keep the pumi, Owner is obliged to provide for the dog's new accommodation and its new owner (with the help of Breeder, if needed). Owner informs Breeder about the change of the dog's ownership.
3. Breeder provides guarantee in case of any hereditary illnesses. If the conditions of the 2nd paragraph of this contract are fulfilled, the guarantee will be 50% of the pumi's price in case of an incidental hereditary illness. The guarantee will be 100% if the dog proves to have heavy hip dysplasia in an examination between its age of 1 to 3 years (except for dysplasia originating from an accident). In this case the guarantee is valid if the following documents are presented: official certification of the Hungarian Pet Orthopaedics Association (MKOE) in Hungary or the official organization of the same function of the given country, and the veterinarian certification of spaying of the dog.
4. (Optional) If the conditions of the 2nd paragraph of this contract are fulfilled, Breeder provides guarantee up to 50% of the pumi's price, if the pumi cannot be used in breeding due to genetic exterior features.
5. Breeder aspires to keep continuous contact with Owner. Breeder helps Owner as far as possible. Owner agrees (after preliminary conciliation) that Breeder from time to time surveys the pumi in order to be able to capitalize on the obtained information and experience in his breeding activity and in order to inform Owner about possible tasks that he might need to do.
6. In case of a dispute, Breeder and Owner seek to find a compromised solution. If the two parties fail to find a mutually acceptable agreement they accept the Budapest Central Court (PKKB) as the court of competent jurisdiction.
